

Subject to the provisions of G.D.C.R. and G.T.P. & U.D. Act 1976, the rules thereof and subsequent order of authority, any registration or written permission granted under this Act may at any time be suspended or revoked by the issuing Authority. If he is satisfied that it has been secured by the holder through misrepresentation of fraud or if any of its restrictions or conditions are infringed of evaded by the person, to whom the same has been granted or if the said person in convicted of an infringement of any of the provisions of any Act or of any rule, or any by-law of standing order in any matter to which such registration or permission relates.
